## Eligibility Requirements & Restrictions:

- Rebates are issued per outdoor unit, not indoor unit. Maximum rebate allowed is \$2000. Processing time is 8-10 weeks. Incomplete applications can add 4-6 weeks to the 8-10 week processing time.
  - Applications require a copy of your installer invoice, which must include an itemized list of units installed, model numbers, SEER, EER & HSPF ratings, and AHRI certificate
  - Appliance purchase must be within 1/1/20- 12/31/20. Applications must be submitted by 1/31/21.
  - Offer is subject to funding and can expire at any time. DED can also terminate the program at any time.
  - Appliance must be installed at service address location.
  - Danvers Electric Division does not warrant, endorse or assume liability for the quality, performance, or safety of the contractor, retailer and/or wholesaler or performance of any appliance or fixture. Responsibility for choosing the product is solely the applicant's. Licensed, insured, qualified installations only. The town of Danvers assumes no liability for installation.
  - The heat pump rebate is tiered at \$250 or \$500 per outdoor system, depending on SEER and HSPF ratings. Central ACs must meet SEER & EER rating listed below.

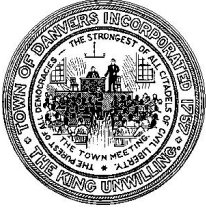
